Title Insurance Highlights for Tract 2 and 3

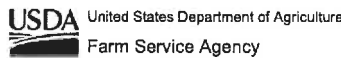
Tract 2

- **EASEMENT AGREEMENT** filed October 2, 1946 and recorded in Book 18 of Misc. Records on Page 208 and entered into with the USDA Dept of Game Fish And Parks for a permanent easement to a strip of ground along the south shore line of Platte Lake 100' wide from the high water shore line as defined by the spillway elevation, and 2550 feet long, for the purpose of constructing a dyke and concrete spillway, to be used as a roadway.
